ARTICLES OF INCORPORATION OF NATIONAL BUSINESS PROMOTIONS, INC.

The undersigned adopt the following articles of incorporation for the purpose of forming a corporation under the Florida Business Corporation Act:

ARTICLE I - NAME

The name of the corporation is NATIONAL BUSINESS PROMOTIONS, INC.

ARTICLE II

The aggregate number of shares which the corporation is authorized to issue is 1000 shares. Such shares shall be of a single class and shall have a par value of \$1.00 (one dollar) per share.

ARTICLE III - INITIAL PRINCIPAL AND REGISTERED OFFICE AND AGENT

The street address of both the initial principal and registered office of the corporation is Route 3 Box 563 E, (Horseshoe Road) Tallahassee, Florida 32308, and the name of the initial registered agent at such address is Herbert A. Abbott.

The Board of Directors from time to time may move the registered office to any other address in the State of Florida.

ARTICLE IV - BOARD OF DIRECTORS

The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.

The initial directors shall hold office for the first year of existence of the corporation or until successors are elected or appointed and qualified, whichever occurs first.

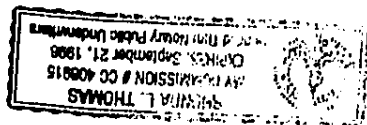

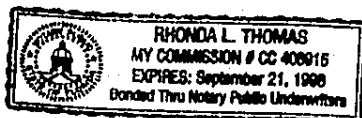
