## Articles of Incorporation of Worldwide Education and Business Services, Inc.

OS INTERPORT STATES

#### Article I Name

The name of this corporation is Worldwide Education and Business Services, Inc.

#### Article II Term of Corporate Existence

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation with the Florida Department of State.

## Article III Permitted Activity

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the United States and Chapter 607, Florida Statutes, as now exists or may herafter be amended.

#### Article IV Authorized Shares
