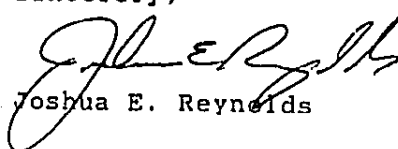

ARTICLE I

Name. The name of this corporation is J.D. MILES CORPORATION.

ARTICLE II

Business and Activities. This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III

Capital Stock. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of voting common stock and -0- shares of non-voting common stock each class having a par value of \$00.10 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors. Except for voting rights, the stock authorized hereby have the same rights and preferences.

ARTICLE IV

Term of Existence. The existence of this corporation shall commence five (5) days immediately preceding the filing of these Articles.

ARTICLE V

Initial Registered Office and Agent. The street address of the initial registered office of this corporation is 4791 Ashton Road, Sarasota, Florida, 34231 and the name of the initial registered agent of this corporation at that address is M. Janie Bertolett.

ARTICLE VI

Principal Office and Mailing Address. The principal office and mailing address of this corporation is 1921 South Osprey Ave., Sarasota, Florida, 34239.

ARTICLE VII

Preemptive Rights. Every shareholder, upon the sale of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

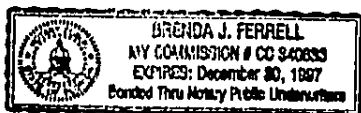
