ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF CERTIFIED CAR TECH, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

RESOLVED, that Article 1 of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:


"ARTICLE 1 - Name. The name of this Corporation shall be CCT LIQUIDATING COMPANY, INC."
