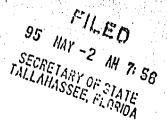

#### ARTICLE I - NAME

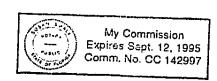

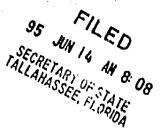
