**SECOND:** The general nature of the business or businesses to be transacted by the corporation are to engage in any activity or business permitted by the laws of the United States and the State of Florida.


**THIRD:** The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares at \$.001 par value.


**FOURTH:** The existence of this Corporation shall be perpetual.



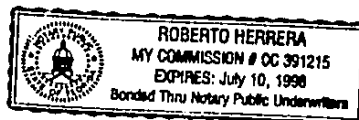


