**ARTICLE I - NAME**

The name of the Corporation shall be **H. T. D. CONSTRUCTION, INC.**  
**INCORPORATED.**

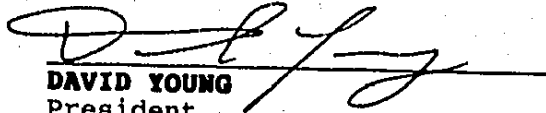

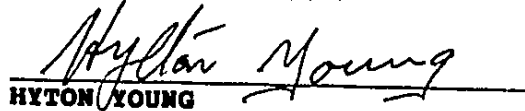

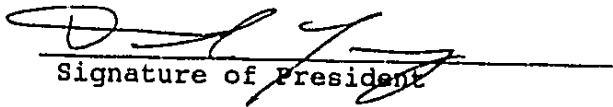
