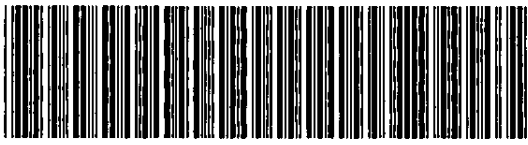

APPROVAL

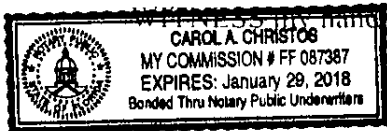
Dissolution of the corporation was approved by written consent of all the Shareholders thus, the number cast for dissolution by the Shareholders was sufficient for approval.


