

**ARTICLES OF INCORPORATION**

**OF**

**PIONEER FAMILY GROUP, INC.**

The undersigned, acting as the sole incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**NAME AND ADDRESS**

The name of the corporation is Pioneer Family Group, Inc. The address of the corporation is 4001 Tamiami Trail North, Suite 330, Naples, Florida 33940.

**ARTICLE II**

**DURATION**

This corporation shall commence its existence on the date of filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III**

## **ARTICLE VI**

### **INCORPORATOR**

## **ARTICLE VII**

of, such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such other corporation, or who is so interested, may not be counted in determining the existence of a quorum and may not participate in or vote at any meeting of the Board of Directors of this corporation which shall authorize any such contract or transaction.

#### ARTICLE X

#### SHAREHOLDERS' PROPERTY

The private property of the shareholders shall not be subject to payment of the corporate debts to any extent.

#### ARTICLE XI

#### INDEMNIFICATION



The corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.

#### REGISTERED AGENT AND OFFICE

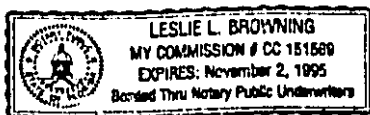
