ARTICLE I - NAME

The name of this Corporation is CD TRADING CORP.

ARTICLE II - PURPOSE

This Corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK

This Corporation is authorized to issue 7,500 shares of one dollar par value common stock.

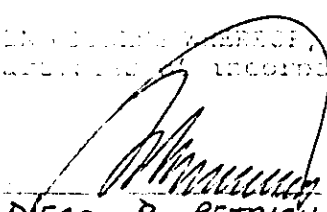
ARTICLE VIII - INDEMNIFICATION

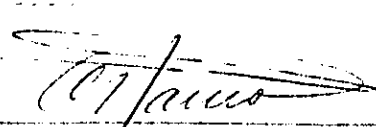

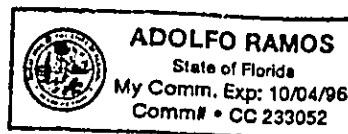

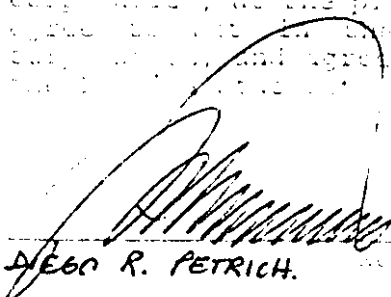
