Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST: The name of the corporation is **CSB SERVICES, INC.**
- SECOND: Article II of the Articles of Incorporation is amended to read as follows:

ARTICLE II. - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida. As needed to pursue the nature of its business, the corporation shall have all the powers granted to it pursuant to Florida Statute 607.0302 and in addition shall have the power to trade on margin and borrow monies against its investments as may be deemed necessary.

- THIRD: The amendment was adopted on the 11th day of August, 2000.
- FOURTH: The amendment was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
- FIFTH: The effective date of this Amendment to Articles of Incorporation shall be this 14th day of Aug., 2000.
