The power to adopt, alter, amend or repeal by-laws shall be vested in the board of directors and shareholders.


ARTICLE X, AMENDMENT

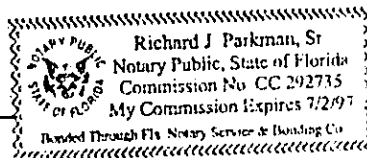


