# ARTICLES OF INCORPORATION

OF

# 1050 CORPORATION

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

# ARTICLE I

NAME

The name of the Corporation is 1050 Corporation.

ARTICLE II

DURATION

The Corporation shall have a perpetual existence.

### ARTICLE III

#### PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### ARTICLE IV

# CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of Ten Cents (\$0.10) par value common stock.

#### ARTICLE V


