**ARTICLES OF INCORPORATION  
OF  
CARUSO LAWN CARE, INC.**

The undersigned, acting as the incorporator for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is **Caruso Lawn Care, Inc.**

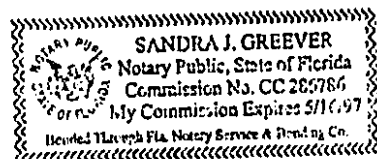


