ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a professional association under the Florida General Corporation Act, adopts the following Articles of Incorporation for such professional association:

1. The name of the corporation is LEFFLER & ASSOCIATES, P.A.
2. The period of its duration is perpetual.
3. The purpose is to engage in any appropriate law firm business permitted under the laws of the United States, the laws of the State of Florida and the Rules Regulating the Florida Bar.
4. The corporation shall have authority to issue 10,000 shares, all of one class, \$1.00 par value.

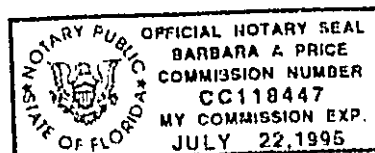


