ARTICLES OF INCORPORATION

We, the undersigned, make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: CLASSIC ERECTING, INC.

ARTICLE II. ADDRESS

The principal place of business of this corporation shall be: 4404 North Grady Avenue, Tampa, Florida 33614.

ARTICLE III. NATURE OF BUSINESS

The purpose of this business is to engage in every aspect of metal building erecting and to transact in any or all lawful activity or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK
