AMENDMENT

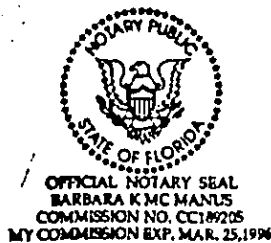

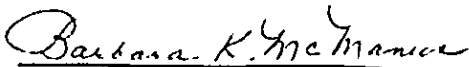
