# ARTICLES OF INCORPORATION OF INCOMEDIATE I

R. & V. BURTON INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of Corporation is: Burton R. & V. BURTON INC.

Article 2. Duration. The duration of the Corporation is perpetual.
