The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **LYON-KING, INC.** The principal place of business of the corporation is 11650 Quail Village Way, Naples, Florida 33999. The mailing address of the corporation is 11650 Quail Village Way, Naples, Florida 33999.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Stated Capital - Classes of Stock

The corporation is authorized to issue 100 shares of common stock at \$1.00 par value.

ARTICLE V-Special Provisions

The Corporation hereby makes the IRC 1244 and Subchapter S elections.

ARTICLE VII- Authorization of Restrictions on Transfer of Shares

All of the issued and outstanding shares of the corporation shall be made subject to restrictions on their transferability by agreement among the holders of such shares. A copy of the agreement shall be kept on file at the corporations principal place of business, and shall be subject to inspection by shareholders of record and bona fide creditors of the corporation at reasonable times.

ARTICLE X - Indemnification

The corporation shall indemnify any officer or director, or person exercising powers and duties of an officer or director, to the full extent now or hereafter permitted by law.

ARTICLE XI - Bylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in Shareholders.

ARTICLE XII - Pre-emptive Rights

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share at the price at which it is offered to others.

ARTICLE XIII - Amendment

The Articles of Incorporation may be amended at any time pursuant to the requirements of F.S. 607.177, et seq., at any regular meeting or at a special meeting called for that purpose.

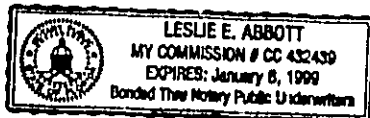

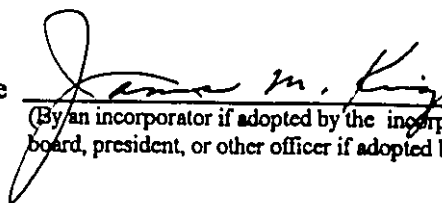
