The undersigned incorporators for the purpose of forming a corporation under the laws of the Florida Corporation Act hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is: EASTERN COMMUNICATION & PAGING INC.

ARTICLE II - NATURE OF BUSINESS

To engage in every aspect of the business of beeper sales and service, and anything else permitted under the laws of the state of Florida.

ARTICLE III - INITIAL STOCK

The amount of capital with which this corporation shall begin business shall be no less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE IIII - CAPITAL STOCK
