ARTICLE I - Name of corporation :

The name of this corporation is :

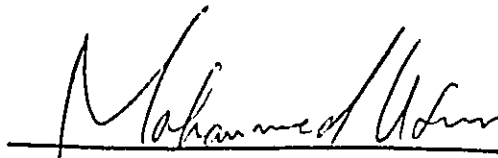
Article IX - Indemnification :

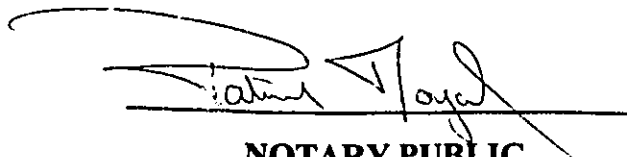

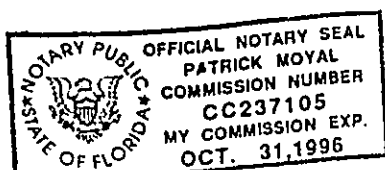
