We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, do hereby form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is:

B & B LAWN MAINTENANCE, INC.

ARTICLE II

The general character of the business to be transacted by this corporation is maintaining lawns. In addition, the corporation may engage in the maintenance of lawns in any activity or business permitted under the laws of the United States of this State. The effective date of this Corporation shall be April 21, 1995.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is One Thousand (1,000) shares of Common Stock, each having a par value of \$1.00. Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this Corporation at any regular or special meeting.

ARTICLE IV

The amount of the capital with which this Corporation shall begin business shall not be less than Five Hundred Dollars (\$500.00)

ARTICLE V

The initial street address of the principal office of this Corporation shall be: 4839 SW 148th Avenue
