ARTICLES OF INCORPORATION

OF

ALUM. A SHIELD SEAMLESS GUTTER, INC.

ARTICLE ONE NAME

The name of the corporation is ALUM A. SHIELD SEAMLESS GUTTER,

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual from the date of incorporation.

ARTICLE THREE PURPOSES

The general purposes for which the corporation organized are:

- 1. Fabrication of sheet metal into seamless gutters, metal roofing, siding, and other materials used in the building industry.
- 2. 
