ARTICLES OF INCORPORATION OF
BREAST IMAGING AND RADIOLOGY ASSOCIATES OF SOUTH FLORIDA, INC.

ARTICLE I - CORPORATE NAME

The name of this corporation shall be Breast Imaging and Radiology Associates of South Florida, Inc.

ARTICLE II - NATURE OF CORPORATE BUSINESS

The Corporation shall be in the business of providing radiological and other medical services and personnel as an independent contractor for numerous health care facilities.

ARTICLE III - CAPITAL STOCK

This Corporation is authorized to issue a maximum of One Thousand (1,000) shares of common stock having a par value of One Dollars (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE IV - INITIAL REGISTERED AGENT

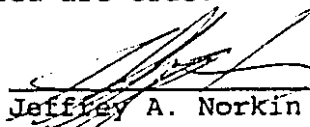

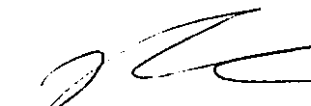
