

ARTICLE I. NAME

The name of this corporation is PAINTING UNLIMITED OF THE VILLAGES, INC.

ARTICLE II. DURATION

This corporation shall begin its existence on the 15th day of May, 1995.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

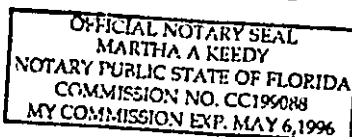


