ARTICLE I. NAME AND ADDRESS. THE NAME OF THIS CORPORATION SHALL BE Green Peacock Nursery, Inc., and its principal office address is : 18455 SW 288 Street, Homestead, Fl 33030.

ARTICLE II. DURATION. THIS CORPORATION IS TO EXIST PERPETUALLY.


