I received your letter dated August 12, 1997, whereupon I contacted your office on August 15th regarding the penalty assessed, per instruction. I am writing this correspondence for the record.

I contacted Ms. Whitfield in your office on June 13, 1997, informing her I was interested in taking control of a defunct Florida corporation that is insolvent and has not shown an income for one year. At the time, the registered agent had moved twice and there was uncertainty if the annual fee was due since she had not informed the state of her change in address, and had not received any mail from the Division of Corporations.

My question to Ms. Whitfield was what I had to do to revive the corporate status. She forwarded the proper documentation to be filed, with oral instruction to enclose \$35.00 for amended filing and \$165.00 for the annual fee; any penalties would be waived due to the circumstances.

After negotiations were completed with the sole shareholder, Articles of Amendment To Articles of Incorporation were forwarded with a \$35.00 check in early July, 1997. Because of a formality, the Articles were returned, corrected and forwarded back; they were accepted by your office on July 28th, now on file. Upon receipt of your filing, we then mailed our annual report with the \$165.00 check, which was returned with a cover letter requiring a penalty be paid. As previously stated, my contact on August 15th showed you have a record of the various mail exchanges and that in this situation, the penalty can be waived. I am therefore, re-filing the report and check.

Your assistance in this matter would be greatly appreciated.
