ARTICLES OF INCORPORATION

OF

RECREATE, INCORPORATED

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporati n for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be RECREATE INCORPORATED.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing as of the date of April 24, 1995

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Corporation Act including without limitation, wholesale and retail sales and distribution of games.
- 2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

EFFECTIVE DATE

ARTICLE IV - CAPITAL STOCK

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 10000 shares of common stock having \$1.00 par value, which may be fractional shares.
- B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value, in the judgment of the board of directors, at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued shall become and be fully paid and non-assessable, the same as though paid for in cash; and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.
- C. Notwithstanding the foregoing, the corporation shall have the right to increase its capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers, of such additional stock, in an amendment to its Certificate of Incorporation.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
