## ARTICLES OF INCORPORATION

OF

### COMMAND AIRCRAFT PARTS AND RECOVERY, INC.

The undersigned subscriber to these Articles of Incorporation, each a natural person, each competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE I.

##### NAME

The name of the corporation is COMMAND AIRCRAFT PARTS AND RECOVERY INC.

#### ARTICLE II.

##### NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States of America and this State, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefits society, state fair or exposition.

#### ARTICLE III.

##### CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having a nominal par value of \$1.00 per share.


AMENDMENT
