

**ARTICLES OF INCORPORATION OF
DISCOUNT JEWELRY AND PAWN, INC.**

The undersigned subscriber, DAVID JOY, a natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE ONE. The name of the proposed corporation is: DISCOUNT JEWELRY AND PAWN, INC.

ARTICLE TWO. Nature of Business. The corporation may engage in any lawful activity or business permitted under the laws of the United States of America and of the State of Florida.
