

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby subscribes himself to these Articles of Incorporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is: **COMPUTER SMART OF STARKE, INC.**

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as provided for in Section 607.0302, Florida Statutes.




