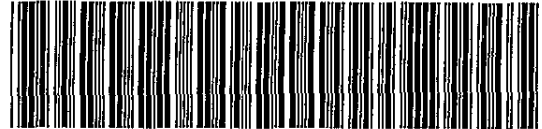



ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION

Pursuant to §607.1006 Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST. The name of the Corporation is Aids Human Resource Centers, Inc.

SECOND. ARTICLE I of the Articles of Incorporation is amended to read as follows:

"ARTICLE I  
NAME

The name of this corporation is "DORSEY CONSULTANT GROUP, INC."

THIRD. ARTICLE II of the Articles of Incorporation is amended to read as follows:

"ARTICLE II  
PURPOSES

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act."

FOURTH. ARTICLE VI of the Articles of Incorporation is deleted in entirety.

FIFTH. The above amendment was adopted and made effective by the Shareholders of the Corporation on the 1<sup>st</sup> day of January, 2003. The number of votes cast for the amendment by the shareholders was sufficient for approval.
