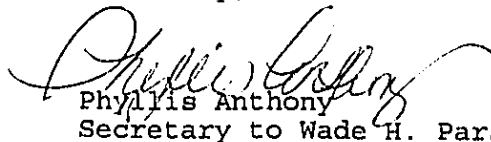

ARTICLE VI - OFFICERS AND DIRECTORS

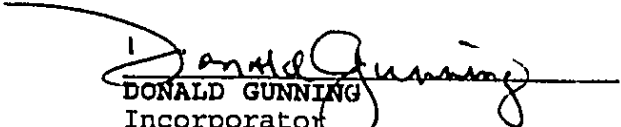
