

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation: EFFECTIVE DATE

ARTICLE I - NAME

4-28-95

The name of this corporation is ADVANCED NECK & BACK PAIN CENTER, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - TERM OF EXISTENCE


ARTICLE VII - INDEMNIFICATION


