# ARTICLES OF INCORPORATION

#### ARTICLE I

95 MAY - 1 PH 12: 52 SECTRE LARY OF STATE TALLAHASSEE, FLORIDA

The name of the corporation is Heatwave Productions, Inc.

## ARTICLE II
