

- 2. Article I of the Articles of Incorporation of CANTINA CORPORATION is hereby amended to read in its entirety as follows:

ARTICLE I. NAME OF CORPORATION

3. Article V of the Articles of Incorporation of CANTINA CORPORATION is hereby amended to read in its entirety as follows:

ARTICLE V. REGISTERED OFFICE AND REGISTERED AGENT
