The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is GREAT LAKES CUSTOMS BROKERAGE, INC.

SECOND: The address, wherever located, of the principal office of the corporation, if known, is 401 North East Mizner Boulevard T618, Boca Raton, FL 33432.

THIRD: The mailing address, wherever located, of the corporation is 401 North East Mizner Boulevard T618, Boca Raton, FL 33432.

FOURTH: The number of shares that the corporation is authorized to issue is 1000, all of which are without par value and are of the same class and are to be Common shares.

SEVENTH: The purposes for which the corporation is organized are to engage

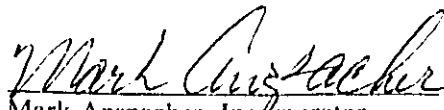
in any lawful business for which corporations may be organized under the Florida Business Corporation Act.

TENTH: Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.

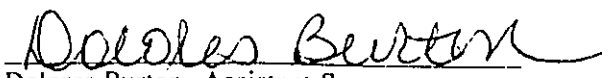
