**ARTICLE I**

The name of this corporation shall be **R & D PROPERTY SERVICES, INC.**

**ARTICLE II**

The principal office and mailing address of this corporation shall be

**ARTICLE III**

This corporation is formed for the purpose of conducting any business or business transaction lawfully permitted by the Florida Business Corporation Act.

#### ARTICLE IV

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 1000 shares of common stock, with a par value of \$10.00 per share, the consideration for which may be paid by money, property, or services as may be fixed by the board of directors from time to time.

#### ARTICLE V

The initial registered office of this corporation shall be located at 9801 N. 21st Street, Tampa, Florida 33612, and the initial registered agent of this corporation shall be **David H. 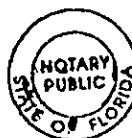
