

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE 1. CORPORATE NAME

The name of this corporation is BUDGET CLEANING AND MAINTENANCE SERVICES, INC.

ARTICLE II. PRINCIPLE OFFICE

ARTICLE III. DURATION

The term of existence of this corporation is perpetual.

ARTICLE IV. PURPOSE

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE V. CAPITAL STOCK
