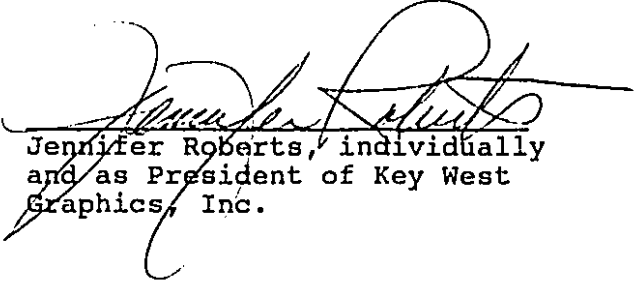
Before me, the undersigned notary, personally appeared Jennifer Roberts, who, upon being first duly sworn, deposes and says:

of

I, THE UNDERSIGNED, a natural person of legal age, acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is Key West Graphics, Inc.
- SECOND: The period of its duration shall be perpetual.
- THIRD: The purposes for which the corporation is organized are the publication, distribution and selling of fine art prints to the public and to the trade. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.
