The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation shall be:

PACKAGING SPECIALISTS, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business of this corporation will be to transact any or all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The principal place of business of said corporation and the address at which service of process upon said corporation within this State shall be made is PACKAGING SPECIALISTS, INC., 136 LAKE BREEZE CIRCLE, LAKE MARY, FLORIDA 32746, with the privilege, however, of having branch offices or places of business at any other place or places within or without the State of Florida, or in foreign countries. MARC L. LUBET is hereby designated as the Registered Agent of the corporation, with address as aforesaid.
