ARTICLES OF INCORPORATION

GENESIS INTERNATIONAL SERVICES INC.

The undersigned incorporator to these Articles OF AHASSEE, FLORIDA Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME
