The undersigned, desiring to form a corporation under the provisions of the Laws of the State of Florida, hereby make, subscribe and acknowledge before a Notary Public, and file with the Secretary of State of the State of Florida, the following Articles of Incorporation for such corporations:

ARTICLE I - NAME

The Name of the corporation is:

MARK R. McCOLLEM, P.A.

ARTICLE II - PURPOSE

The general nature of the business to be conducted and carried on by this corporation is:

- (a) Attorney at law;
- (b) To engage in every aspect and phase of each and every lawful business or operation permitted by the laws of the State of Florida, including, but not limited to, the right and power to manufacture, distribute, purchase, or otherwise acquire, and to own,
