ARTICLES OF INCORPORATION



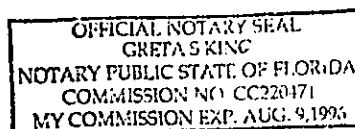


