ARTICLES OF INCORPORATION of HERON BAY GOLF COURSE PROPERTIES, INC.

THE UNDERSIGNED, acting as the Incorporators of a corporation pursuant to the Florida General Corporation Act, hereby adopt the following Articles of Incorporation of HERON BAY GOLF COURSE PROPERTIES, INC., a corporation under the laws of the State of Florida.

ARTICLE I
