ARTICLES OF INCORPORATION

The undersigned, being individuals, do hereby act as incorporators in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

- I. The corporate name for the corporation (hereinafter called the corporation) is LMT TECHNOLOGIES, INC.
- II. The address, wherever located, of the principal office of the corporation, is 608 Wildflower Court, Longwood, Florida 32750.
- III. The mailing address, wherever located, of the corporation is 608 Wildflower Court, Longwood, Florida 32750.
- IV. The number of shares that the corporation is authorized to issue is 500, all of which are at \$1.00 par value and are of the same class and are to be Common shares.
- V. The street address of the initial registered office of the corporation in the State of Florida is 606 Wildflower Court, Longwood, Florida 32750.
