ARTICLES OF INCORPORATION  
OF  
SUPER CLEAN LINEN, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLES I

The name of the corporation shall be:

SUPER CLEAN LINEN, INC.

ARTICLE II

The initial post office address of the principal office of this corporation in the State of Florida shall be 6010 W. Oakland Park Blvd, Sunrise, Florida 33313. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Seven Thousand (7000) shares of common stock with a par value of One (.100) Dollar per share. The actual consideration to be paid for each share shall be fixed by the Board of Directors.


## ARTICLE XII

## ARTICLE XI




