The name of the corporation is PDJ, Inc., a Florida corporation.

DURATION

The term of existence of the corporation is perpetual; and the corporate existence will commence on the date of April 14, 1995 . . .

PURPOSE

The corporation is organized for the purpose of holding title to real property, as well as the maintenance and conducting of all lawful activities.

DIRECTORS

There shall be one (1) member of the initial Board of Directors of the corporation. There shall never be less than one (1) director, nor more than thirteen (13). The manner of electing directors shall be set forth in the bylaws.

SHARES

There shall be two (2) classes of stock, class A and class B. The corporation shall be authorized to issue 3 shares of class A stock, par value \$1.00 per share, and 36 shares of class B stock, par value \$1.00 per share.
