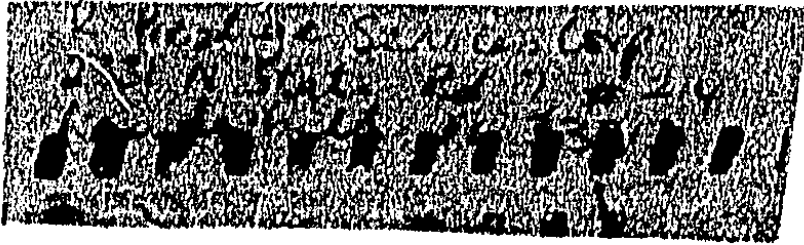

#### ARTICLE II. NATURE OF BUSINESS

#### ARTICLE III. CAPITAL STOCK

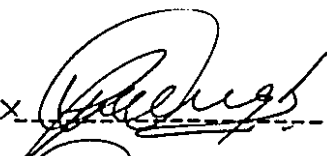
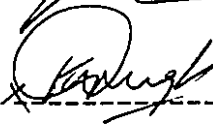
#### ARTICLE IX. OTHER PROVISIONS

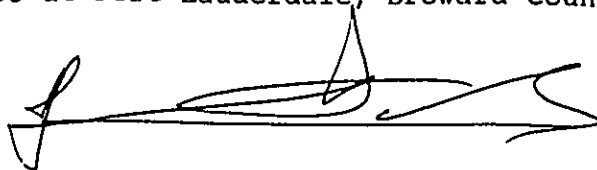

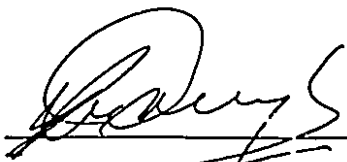
