ARTICLES OF INCORPORATION

OF

AVTV CORP.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: AVTV CORP.

The address of the principal office of this corporation shall be 5701 Collins Avenue, PH-10, Miami, Florida 33140, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
